Policy title: SBS FACULTY ADVISORY COUNCIL (formerly SBS Faculty Advisory Committee)

Effective: January 7, 2013

### **PURPOSE/INTENT**

This policy establishes the goals, eligibility, and procedural requirements related to the College of Social and Behavioral Sciences' Faculty Advisory Council (FAC), formerly the SBS Faculty Advisory Committee.

The primary aim of the FAC is to advance dialogue around topics of importance and to advise the Dean on issues of collective concern.

### **SBS PROCEDURE**

#### **SBS Faculty Advisory Committee Goals**

The role of the SBS Faculty Advisory Council is to advise the Dean on emerging matters of College or University importance. The Faculty Advisory Council will be composed of seven faculty members, rank open, a minimum of four of whom have tenure or continuing status. The seven members will be elected to three-year terms, with no more than one representative from any program and no more than two from any department or school. In addition to the seven active members, two alternates will be elected. The two alternates will serve on the Council in the case of temporary member absence (sabbatical or leave, for example) or vacancy.

#### **Eligibility to serve on the SBS FAC**

The SBS policy utilizes the definition of faculty as per the Constitution of the General Faculty of the University of Arizona:

- a. Individuals who hold at least half-time tenured or tenure-eligible faculty appointments,
- b. Academic professionals who hold at least half-time continuing or continuing-eligible appointments,
- c. Individuals who hold at least half-time multi-year Career Track appointments,
- d. Individuals who have held at least half-time year-to-year Career Track faculty appointments for three (3) of the past four (4) years and who currently hold lecturer or ranked professorial titles that do not include an adjunct or visiting modifier, and
- e. Individuals who hold Emeritus status.

Additional conditions of eligibility can be viewed in the *Constitution of the General Faculty of the University of Arizona* (see Article II, Members).

### Voting procedures and Processing for SBS Faculty Advisory Committee:

1. The call for SBS FAC faculty nominees will go out in the Spring semester each year for service starting the first day of the Fall semester. Faculty interested in running for an FAC seat will submit a ~250-word statement and CV, with a due date indicated in the FAC call from the Dean's Office.
2. The Dean's Office will gather nominations and confirm eligibility to serve on the FAC. The statements and CVs will be distributed at least two weeks prior to voting.
3. Voting will be open to all SBS faculty, as defined above, with at least a .50 appointment in the College.
4. Voting is done anonymously via online ballot.
5. Each election will yield a total of nine members: seven active members (the five nominees who receive the most votes), and two alternates (the two nominees who receive the sixth and seventh highest vote totals). Alternates do not come to meetings but do fill vacant spots either temporarily (in the case of sabbatical or leave of absence) or permanently (as in the case of retirements) until the Fall semester following the next election.
6. Committee members will be elected to serve on three-year staggered terms, which will ensure continuity. Alternates are elected to one-year terms.

In the event that a majority vote produces a committee that does not meet FAC composition constraints (i.e., a minimum of four tenured or continuing status faculty), the Dean will appoint people in that category from the current nominees so as to constitute a majority. If there is no appropriate alternate, the Dean may appoint a temporary alternate, with the majority approval of the Faculty Advisory Council, to fill a position until the end of the academic year.

This voting procedure is subject to evaluation by the first FAC, who will have discretion in amending the voting procedures.

### CONSIDERATIONS

The first meeting of every Fall semester will be overseen by the Dean or Associate Dean, who will ask the group to nominate and elect a Chair. Following that first meeting, the FAC will establish a monthly meeting schedule.

Alternates and all faculty members whose terms have expired are eligible to run for another term at the end of their service (regardless of if their initial term was one, two, or three years). Faculty may serve up to six consecutive years on the FAC. A three-year period of non-FAC service is required before a faculty member becomes eligible for further terms.
