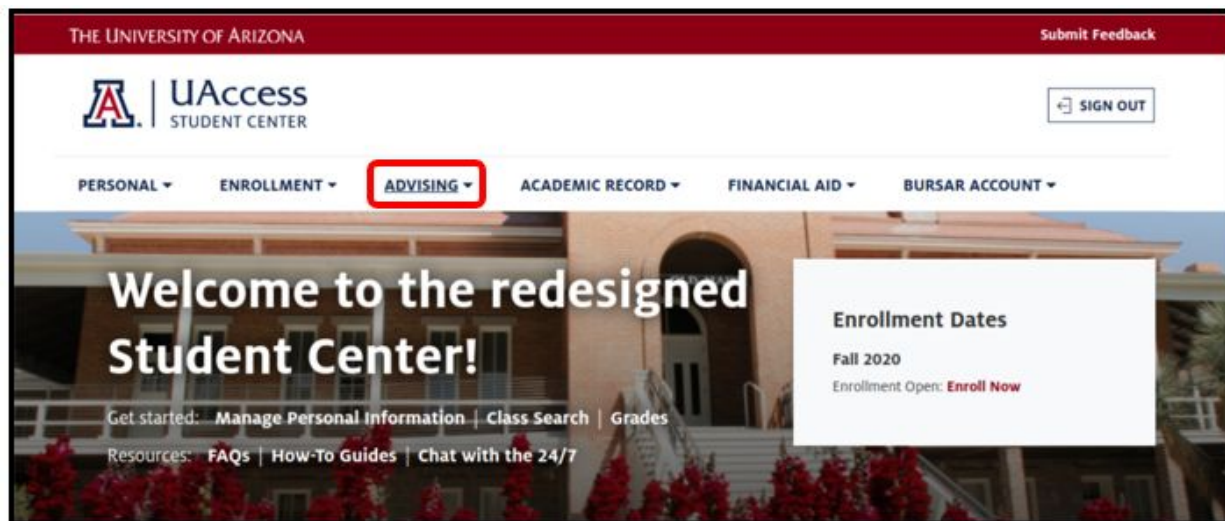


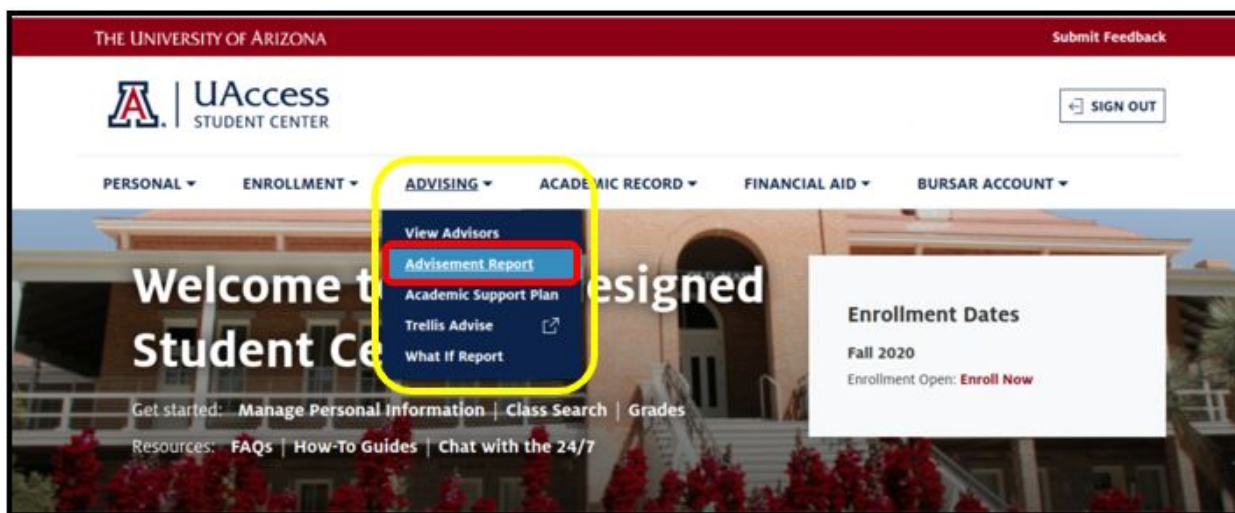
How to View Your Advisement Report (PDF)

1. Login to your [UAccess Student Center](https://uaccess.arizona.edu/) with your NetID and Password: <https://uaccess.arizona.edu/>
2. Once the homepage loads, it should look like this first image. Click the tab titled "**ADVISING.**"
